RE: POST COVID-19-INJECTION EXCESS DEATHS

Dear Mr Moran,

We have come here today, as deeply concerned men and women of éiRe, to publicly highlight to you as Mayor of Limerick, the fact that since the rollout of the Covid-19 injection in 2021, there has been a horrific increase in excess deaths in every village, in every town, and in every county of éiRe.

Excess Death statistics are a measurement of the difference between the ‘actual’ all-cause mortality and the ‘expected’ mortality under normal conditions. This is the gold standard for evaluating the health of a nation. A number of different calculation methods can be used, and the statistics we present to you here today were determined using the five-year rolling-average method.

You, John Moran, Mayor of Limerick, with a professional background in law and investment banking, must surely possess an advanced understanding of the real-life implications expressed in significant changes in pertinent statistics and data. It is incumbent on you to immediately prioritise a campaign to inform the people of Limerick about the staggering post-Covid-19-injection excess deaths that we present in the below chart.

These figures are analysed from RIP.ie which is recognised by the General Registers Office and the Central Statistics Office as a real time measure of mortality in Ireland.

These statistics demonstrate that even in 2020, previous to the injection rollout, there were no alarming increases in excess deaths except for in one month, that of April 2020. This occurred when our elderly people were moved from hospitals to nursing homes and resulted in more than 1,000 precipitated deaths.

Since the injection rollout there was only one month, March 2021, when there was no increase above the baseline value of the previous five-year average. In December 2020 the government launched the Covid-19 injection and in the following months of January and February 2021 there were shocking increases of 800 and 700 deaths respectively. In 2021, these statistics should have been enough for all Official Ireland employees who monitor such things to immediately raise the alarm, but they all remained silent, and the injection rollout continued.

Further post-injection analyses show continuous increases in deaths, with only the months of April, May and June 2021 having increases below 100-200 people. Eight of the months show an increase of between 200-400 people. Twenty-three of the months show an increase of between 400-600 people, and there were a further seven months where the increase was more than 600 people, with 3 of those months showing an increase of 800 or more people.

These are not just numbers, they represent souls who died prematurely, who were misled and betrayed. Some even died alone in hospitals without the comforting presence of loving family members. We would all like to believe that any decent and sensible person in a position of public responsibility could not, and would not, ignore this. But this carnage is still being ignored, bringing us to the dreadful situation of statistics demonstrating that over 18,800 extra souls have left this life since the Covid-19 injection rollout. These figures do not count all the babies who died by miscarriage, which is now a known risk of the Covid-19 injections.

While the people of Limerick were living the glory years of four-in-a-row All-Ireland victories, proudly chanting Luimneach Abú and singing our beloved Cranberries songs, with green-and-white flags adorning the Walls of Limerick, Official Ireland was staying silent about the stealth death and injury of our people.

For all those in Official Ireland who continue to shirk basic care and attention to the people they serve, we would like to point out that there is a large amount of validated information and studies freely available in the public domain, including the manufacturing safety data from the producers of the Covid-19 injections, which highlight that the producers knew these injections were never actually safe. All relevant regulatory bodies now admit that the C-19 injections have already caused millions of deaths and have also maimed hundreds of millions of people worldwide. There are data-backed studies proving the correlation between the Covid-19 injections and post-injection excess deaths still occurring in all heavily injected countries. We have provided you several links to verify the above statements.

There are no hiding places now. Any public representative who states that he or she 'did not know' is displaying dangerous stupidity, immoral evasion of their duty to the public, and a childlike naivety out of touch with our living reality.

The whole world was paused for the coronavirus, a virus that posed no real threat to 99.97% of the people that contracted it. An international emergency was declared and then an untried injection, using new pharmaceutical technology, was given to more than four million Irish men, women, and children.



Elected representatives, working during or after such novel and extreme circumstances, have a duty to observe, monitor and register significant changes in their community, in statistics and in data. Public representatives have a basic duty to be aware of what is happening in their area. They can easily check with local hospitals, ambulance staff, GPs, nurses, priests, and funeral directors. Even the florists of Limerick must have noted an increased demand for funeral wreaths in these years. Yet, Official Ireland is choosing to avoid this awful truth.

In éiRe funerals have always been especially important. There is now a higher number of funerals to attend, and decent people are recognising this, as well as the other glaringly obvious signs that something profoundly serious and very wrong is happening in our country.

Decent and caring people are often hesitant to use alarmist language, but there is by now compelling evidence that a stealth and quota genocide is taking place in our country.

The decent people of éiRe are beginning to digest the abhorrent truth that most public representatives that should be speaking out are not doing so, and that those individuals are cowardly adhering to the deadly code of silence on the carnage after the Covid-19 injection. The people are also having to accept that they have been betrayed, that they were misled to believe this injection was not only ok, but it was also “safe and effective” and necessary for the protection of others and a return to pre-Covid life.

Limerick is the land of musicians and poets, of Brian Merriman and the Cranberries. We have our songs, “Limerick, you’re a lady. Your Shannon waters tears of joy that flow. The beauty that surrounds you, I take it with me love where ‘ere I go.” But now we will be writing new songs to record this ugliness when tears of sorrow and death flowed freely in our city and across our land.

As the people’s elected Mayor of Limerick, you are duty bound to serve and protect the people of Limerick, and indeed the wider Irish population, from significant known harms or dangers. Informing the people about the Covid-19-injection facts should now be your most urgent top priority. Anything less will be viewed as a gross neglect of duty and a complete breach of the trust that has been placed in you. Feigning ignorance or sticking one’s head in the sand is not an option. This dangerous injection, which proved to be a final solution for thousands of socially coerced and/or trusting citizens, is a contemporary ‘open secret’ in a society where officialdom facilitated the continuation of a quota genocide of their own people. It does not get any worse than this.

Tens of thousands of concerned thinking people of éiRe have become so alarmed at the situation that they are now researching the entire Covid-19 injection phenomenon. This is the morally correct and intelligent thing to do. Official Ireland continues to marginalise and discriminate against people who question the injection, initially by calling them anti-vaxxers and currently by insisting that everyone continues to blindly believe in the lies, the coercive policies and mandates that led them into an untested medical trial.

These good and decent people will continue to stand their ground with moral integrity, despite an Official Ireland that uses the threat of anti-hate speech laws in an attempt to silence the people. These good and decent people of éiRe will never stay silent, as silence for them is worse than death itself.
